The duration for traineeship in medicine is 2 to 4 months; the students must have completed two years of Master in medicine and have a good knowledge of French (B2 level).

A mandatory Welcome and Orientation Session is organized by the Academic Exchange Office at the beginning of the Semester to guide exchange students through the main administrative matters relating to their stay (residence permit, health insurance, banking, etc.). For academic purposes, the exchange students will also be invited to attend a Faculty welcome/information session which is also mandatory.

### 3. Recommended language skills

The main language of instruction is French. Specific courses are given in English (for more details on the language of instruction, please refer to our [course catalogue](#)).

Students taking courses in French are expected to have a good command of French (level B2\*).

**Mandatory B2** level for Faculty of Psychology and Educational Sciences (FPSE).

**Mandatory B2** level for Faculty of Arts/Humanities (Lettres).

**Mandatory C1** level for French literature courses in Faculty of Arts/Humanities.

Our École de langue et de civilisation françaises ([ELCF](#)) offers different opportunities to learn and improve French for students with level below B2:

[Année d'immersion](#) (linguistic and cultural courses): From A2 level to ideally reach a B1.

[Année propédeutique](#): From B1 level to reach a B2.

Before the exchange:

Fee-paying French courses during the summer and winter holidays (see <https://mdl.unige.ch/fr/cours-dete-de-francais/cours-dete/histoire>) just before the beginning of the semester. Exchange students may benefit from a discount on fees (registration link for discount provided after registration).

During the exchange:

Exchange students can attend a free French support course each semester (we offer up to two courses of two hours each per week). The course starts after the beginning of the semester (more information during the orientation session: <https://www.unige.ch/coursappui/en>). It is possible to receive 3 ECTS for each course.

Students taking courses in English are expected to have a good command of English (level B2\*).

### 4. Academic Preparation

Before coming to Geneva, students should select the courses they wish to attend using the course catalogue: [www.unige.ch/progcours.html](http://www.unige.ch/progcours.html) or the website of the Faculty/Institute/Department. The yearly course catalogue is published every summer. Fall semester applicants must base their selection on courses from the previous year and adjust later. It is possible to browse by faculty, department, semester, level and teaching language.

We invite the students to pay special attention to the semester (automne/fall or printemps/spring) and the level (Bachelor, Master) of each course they would like to attend.

Students must fill in a provisional list of courses (study plan) during the online registration process. The academic advisors in Geneva may suggest amendments and will validate it (see below 6. Acceptance Process).

#### 4.1. Restrictions

- Students at the Bachelor's level are not allowed to take courses at Master's level (except courses from the Faculty of law).
- The students have to choose courses mainly in the Faculty/Institute of the agreement.
- Courses may be chosen from two different Faculties/Institutes at the most.

## 5. Nomination, Admission and Registration Procedure:

### 5.2. Online Student registration deadlines and requirements:

Autumn Semester/Full Year	May 1
Spring Semester	November 1

Students will receive a personal email requesting them to register online, with the link and an access code to the registration platform.

During online registration, the following documents MUST be uploaded:

- Transcripts of records (copy of the official grades/courses from your university) (PDF format)
- Photo: high quality and respecting the same requirements as for an official ID/passport (JPG format, exact ration 3:4)
- Copy of the data and picture pages of your passport (PDF format)
- For courses in French: test certificate or UNIGE French test result (PDF format)

**Reminder:** Students must fill in an expected list of courses (provisional study plan) during online registration. Even if changes might be done once in Geneva, we ask the students to draw the most suitable study plan for them. The study plan is submitted to the academic advisors for approval then we send the validation and comment as well as a Learning agreement for signature to the students.

**Please note that it is not possible to transfer current (home university) accommodation directly to the UNIGE.** The student will have to submit a new petition to UNIGE which includes medical certification.

Possible accommodations:

- **Accommodation of examination conditions:** one-third time increase, use of a computer provided by the UNIGE, tolerance for spelling mistakes, voice synthesis software.
- **Accommodation of study conditions:**
  - Technical assistance (softwares, access to magnetic loops,).
  - Human assistance: help from another student for handling documents, mentoring (FPSE), coaching
- **Study plan accommodation:** part-time studies. Please directly contact the dean's office of your faculty/centre/institute or contact the academic advisors.

## IMPORTANT :

- We do not have small rooms available to limit noise during the examination
- Examination terms and conditions cannot be changed: an oral examination cannot be replaced by a written one and vice versa
- The maximum amount of extra time allowed is one-third in a sitting exam
- No additional time is allowed for the return of homework

## 6. Acceptance Process

Applications are sent to Faculties for approval. Academic advisors in Geneva may suggest amendments to the provisional list of courses and will validate it.

Letters of acceptance will be sent on a first come – first served basis.

### 7.1. Visa and Residence Permit

- EU and EFTA citizens do not need a visa to enter Switzerland but like all foreign citizens, they need a residence permit. EU and EFTA citizens apply once arrived in Geneva for a residence permit.
- Non-EU citizens may require a visa and must contact the nearest Swiss embassy 3 to 5 months before entering Switzerland in order to inquire about the visa procedure and/or the residence permit.

**NEW since August 2022:** Third state members<sup>1</sup> (non-Schengen) in possession of both a valid residence permit issued by a Schengen member state or a valid type D visa and a recognized and valid travel document are exempt from visa requirements.

For example, a student with a Chinese citizenship holding a valid French residence permit (Schengen) during the studies does no longer need a visa to come to Switzerland. Nonetheless, as any person staying more than 3 months in Switzerland, the student will need to apply for a Swiss residence permit.

The visa will allow entry into Switzerland. Students should also request a residence permit from the Geneva Migration Office (OCPM) prior to arrival in Switzerland, by regular mail.

### 7.2. Housing

It is difficult and expensive to find accommodation in Geneva. The University Housing Office ("[Bureau des Logements](#)"- [BLOG](#)) and "[Cité Universitaire](#)" provide student residences. Due to a high demand and low availability, there is no guarantee that all the applications receive an offer.

**IMPORTANT:** Please note that the BLOG will give priority for students requiring a visa to come as well as for students coming from university member of the [4EU+ Alliance](#).

### 7.3. Cost of living in Geneva

The average cost of living for a student in Geneva is approximately CHF 2,000 per month. This includes rent (~CHF 500\*), food and basic necessities (~CHF 600), and health insurance (~CHF 100). *\*Housing in student residences. The cost on the private market might be at least twice.*

Students will have to prove financial capacity (statement of account and assets), both for visa and residence permit requests.

### 7.4. Insurance

Health insurance is mandatory in Switzerland (accident and health). Students may request recognition of their private insurance or subscribe to a student insurance plan upon arrival in Switzerland (about CHF 100 per month). European Health Insurance Card is recognized in Switzerland for health and accident insurance as long as the student does not work in Switzerland (including unpaid internship).

### 7.5. Termination of Agreement

In the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1.

### 7.6. Transcripts of Records

A Transcript of Records will be issued no later than 5 weeks after the assessment period has finished at our institution. Transcript will be sent by the Faculties to the student's address in Europe.

### 7.7. Grading system

The University of Geneva uses a grading scale ranging from 0 to 6.00, with 4.00 representing a passing grade. Furthermore, grades are converted into a letter system ranging from A to F (hereafter known as the ECTS scale), in line with one of the objectives of the Bologna reform. This conversion facilitates comparison amongst different European grading scales.

## 8. Scholarships

Unless stated otherwise, eligible students selected for a Swiss-European Mobility Programme exchange at the University of Geneva will receive a scholarship from the University of Geneva. This is contingent upon having a signed valid agreement. The scholarship is given for 5 months (1 semester) or 10 months (2 semesters).
