

Information sheet on Article 13 of the EU General Data Protection Regulation

The following information must be provided to you in accordance with Article 13 of the General Data Protection Regulation (GDPR, Regulation (EU) 2016/679) when collecting personal data:

- Regarding Art. 13 para 1 a) und b)

The entity responsible for collection and processing personal data pursuant to Art. 4 No. 7 GDPR is the Georg-August-Universität Göttingen Foundation under Public Law (excluding University Medical Center), Wilhelmsplatz 1, 37073 Göttingen, represented by the President (hereinafter: University of Göttingen). The specific data-processing unit is the section for teaching and learning in higher education within the framework of the Conference for Student Research on September 24 and 25, 2026 (StuFo 26).

- Regarding Art. 13 (1) c):

The collection of personal data is necessary in order to

- Clearly assign registrations/submissions
- Communicate with participants before, during, and after the conference
- Issue confirmations of participation
- Evaluate the participant structure for the proper planning and execution of the conference

and is based on your consent in accordance with Art. 6 (1) (a) GDPR in conjunction with § 13 NDSG (legal basis).

- Regarding Art. 13 (1) e):

Personal data will be further processed and transferred to other competent bodies as follows:

o Conference: The data collected during the student research conference (StuFo 26) will be processed by the section for teaching and learning in higher education. If there are other recipients of the data, you will be notified separately.

- Regarding Art. 13 (2) a):

In accordance with the guidelines of the German Research Foundation (DFG) on good scientific practice, data is stored for 10 years. In any case, personal data will be deleted as soon as it is no longer needed. Wherever and whenever possible, data will be anonymized.

- Regarding Art. 13 (2) b):

The data subject has the right to obtain from the section for teaching and learning in higher education information about the personal data concerning them and, where applicable, to have this data corrected, deleted, or restricted, as well as the right to object to the processing of this data. The right to data portability does not apply to the performance of public tasks (university research). These rights can only be exercised as long as the data can still be attributed to you. The right to negative information and to lodge a complaint with a supervisory authority remains unaffected.

- Regarding Art. 13 (2) c):

If data processing is based on your consent, you have the right to withdraw your consent at any time. Data processing that has taken place up to that point remains lawful; the withdrawal only applies to the future. In this case, your data will be deleted immediately.

- Regarding Art. 13 (2) d):

The data subject has the right to lodge a complaint with a supervisory authority responsible for data protection (Art. 77 GDPR).

- Regarding Art. 13 (2) e):

The provision of data by you is purely voluntary.

- Regarding Art. 13 (3):

If it is intended to further process the personal data for a purpose other than that for which it was originally collected, the University of Göttingen or [the faculty or other organizational unit] shall provide the data subject with information about this other purpose and all other relevant information prior to such further processing.
